#### **GYPSY MOTHS - I KNOW I HATE 'EM**

The gypsy moth is an exotic pest of urban and forest trees and believed to be a native of Europe. The caterpillars are voracious eaters and in large numbers can cause defoliation of trees. Like all moths and butterflies, the gypsy moth in one year will change from an egg (found in one-inch furry masses on tress) to a larva caterpillar, to a pupa, to a reproducing adult.



Although, when in large numbers, they can drastically stress trees, healthy trees usually survive because of energy stored in their roots. During an outbreak such as this, its best to make sure your trees are getting enough water, if possible. This will help their survivability.

Montmorency County has been hit hard this year and is currently looking at the potential for targeted spraying in early 2021, depending on funding.

## So, what can landowners do to manage or mitigate gypsy moths without spraying?

For backyard situations, keep trees well-watered, but do not fertilize. Reduce the number of egg masses by scraping them off the trees in late winter or early spring. Place the egg masses in a soap and water solution for a few hours or burn them. Later in the spring, emergent caterpillars can be impeded and collected by barrier and collection bands that prevent them from scaling up the tree. One example is wrapping the base of a tree with duct tape, sticky side out.

There are natural predators although many birds do not like the caterpillars. Blue jays and orioles do. Small mammals such as mice and voles will feed on the caterpillars as well.

## NPV (nucleopolyhedrosis) – The Virus Disease

The NPV disease is usually the most important factor in the collapse of a gypsy moth outbreak. The good news is it only effects gypsy moths and since they refuse to socially distance or put on little masks, the virus proves to be deadly in almost all cases. The disease usually occurs one to two years following an outbreak. A gypsy moth that has contracted the NPV will form a V-shape as it dies. Experts tell us to leave these V-shaped caterpillars where they are because they will spread the virus even after they are dead.

## **TLPOA TIDBITS**

#### **SWIMMING BUOYS**

The TLPOA was again contacted by a property owner and member of the TLPOA regarding the placement of swimming buoys. While the TLPOA Board is not an enforcement arm of the law, we want to take this time to first acknowledge there have been some reported close calls this past summer with people swimming off their shoreline and watercraft coming dangerously close. While this may be the reason for someone placing swimming buoys in front of their property, Michigan law prohibits them without first obtaining a permit from the DNR.

#### **AERATION - EAST TWIN**

The Board approved replacing the remaining two old compressors at a cost of \$8,500. This amount was not reflected in the second quarter financial report due to the bill being paid after June 30<sup>th</sup>. The Board is reviewing potentially placing diffusers in other locations of the lake.

Measurements to determine muck levels will be taken by Clean-Flo Maintenance personnel when they conduct spring maintenance on the system.

#### **EURASIAN WATER MILFOIL - WEST TWIN**

Since first being confirmed on West Twin in the fall of 2014, Eurasian watermilfoil (EWM) has been kept from becoming a widespread issue. PLM Lake and Land Management has been out on our lakes in June and July conducting surveys for EWM and doing spot treatments as necessary. They are scheduled to return on August 24, 2020, weather permitting. If you see a suspicious looking bed of weeds and want someone to check it out, let us know via email. Include GPS coordinates if possible.

Because of past generosity of our membership and much lower costs in treating EWM, the Board of Directors suspended requests for donations to this fund in 2020.

#### **RETENTION POND**

With the outbreak of Covid-19, there has been little activity to report. We are still interested in partnering with Huron Pines and local governments to install rain gardens as a means of capturing water run-off.

#### **WATER TESTING**

Water testing continues to be conducted by volunteers John Jackson and Jerry Beatty, despite the lack of funding given to the Cooperative Lake Monitoring Program (CLMP) in 2020. We've also worked with health department officials to expand E. coli testing on East Twin. Results forthcoming.

## **BEACH PARTY 2021**

Yes. The TLPOA does plan to host a Beach Party at the East Twin public beach some time in 2021. Karen Wilding has agreed to again volunteer to coordinate. If you think you'd like to help, send us an email.
